- 1. The Directions are established in order to encourage NTHU students to broaden their international perspectives and improve their international competitiveness.
- 2. NTHU students who are recommended or selected by any Taiwanese government agency or any unit of NTHU to engage in research, exchange programs or full-time internships, or attend training on behalf of Taiwan or NTHU, overseas, are allowed to apply for waiving one course, for one semester, and two courses, for two semesters. In the case of any special circumstances, students may submit their explanation to the Vice President for Academic Affairs for review and approval.
- 3. Applicants shall submit a copy of the official document certifying their recommendation or selection and complete the "Application Form for Waiver of Courses for Overseas Full-Time Internship/Training" (as attached). The application shall be submitted to the Division of Registration in the case of any required course of NTHU to be waived, or to the department, institute or degree program in the case of other courses, for the preliminary review, and then to the Vice President for Academic Affairs for approval.
- 4. Once the application is approved, the waiver will be recorded by the Division of Registration in the case of any required courses of NTHU, or by the department, institute or degree program in the case of other courses, at the time of graduation qualification review.
- 5. No credit will be earned for any course waived. Students are still not allowed to graduate until they make up the minimum graduation credits required by the various degrees.
- 6. Matters not covered herein shall be governed by NTHU's related requirements or resolution made by any related meeting.
- 7. The Directions shall be enforced upon approval of the Faculty Meeting and authorization by the President.
